## Connecticut Pistol & Revolver Permit Safety Course

This Pistol/Revolver Permit training class is taught by [Reginald F. Allard, Jr.](#) Mr. Allard's Permit Lesson plans are approved by the [Department of Public Safety - Special Licensing and Firearms Unit](#) pursuant to Connecticut General Statute § 29-28(b). Mr. Allard is a retired Connecticut Law Enforcement officer with 35 years of Police Command level and training experience. Mr. Allard is currently the President of the company ([13thjuror, LLC](#)) specializing in the Fourth Amendment and counter-part State Constitutional Police Excessive Force Litigation.

**Target Audience:** Persons required by Connecticut General Statutes §29-35 to obtain a Connecticut Firearms Permit to Carry a Pistol/Revolver. General Statutes §29-35 provides: "No person shall carry any pistol or revolver upon his person, except when such person is within his dwelling house or place of business, without a permit to carry the same issued as provided in section §29-28.

Curriculum Area: **Basic Pistol Course - Handgun Safety - Weapons and Permits**

Method of Presentation: Lecture, Discussion & Live Fire Weapon Proficiency

Time allotted: Ten(10) Hours - Students will demonstrate proficiency of a live-fire semi-automatic pistol or revolver course of Fire.

The Student **will provide or have provided** to them a pistol/revolver, holster, ammunition, safety glasses and ear protection for the live fire proficiency course. (Indoor Range Qualification requires a .22 caliber Pistol/Revolver; Outdoor Qualification can be any caliber handgun of choice)

**Objectives:** At the end of this unit of instruction, the student will be able to:

1. Identify The Connecticut General Statutes relative to the illegal sale, carry, possession, and safe storage of handguns/firearms.
2. Identify the Connecticut General Statutes that refer to various permits and permit application and revocation procedures.
3. Explain and understand the nomenclature and operational mechanical function of a pistol/revolver.
4. Understand Connecticut General Statutes: Use of Force - 53a-19; 53a-20; 53a-21; 53a-22
5. Understand handgun Bullet Ballistics.
6. Perform Proper Stance - Grip - Sight Picture - Squeeze ( Trigger Control ).
7. Perform Pistol/Revolver Handgun Holster Draw from Concealed Condition of Carry or from a 'Bench Rest Position'.
8. Identify procedures for Handgun Storage in accordance with the United States Constitution 2nd Amendment re: District of Columbia v Heller/ Connecticut Article 1 Section 15 and Connecticut State Statutes 53a-217a, 29-37i, 53-21- Risk of Injury to a Minor.
9. Understand and Perform Range - Gun Safety Rules. Condition of concealed carry, Weapon Draw and Brandishing low-ready shooting position; High-ready shooting position; Live fire trigger control.
10. Satisfactorily Demonstrate Proficiency of the attached Live Fire Basic Pistol Course of Fire. Proficiency score - 80 % on target hits ( 20 hits ) out of 25 Bullets fired.

# ***Basic Course of Live Fire - Firearms Safety Course***

**25 round course - Firearms Range**

**7 yard line - hit target - 5 bullets - Safety on Holster/Bench Rest Position  
- Action Open**

**7 yard line - hit target 5 bullets - Safety on Holster/Bench Rest Position -  
Action Open**

**4 yard line - hit target - 5 Bullets**

**pause - low ready position**

**4 yard line - hit target - 5 bullets**

**7 yard line - hit target one bullet - Safety on Holster/Bench Rest Position  
- Action Open**

**7 Yard Line - hit target two bullets - Safety on & Holster/Bench Rest  
Position - Action Open**

**4 yard line - hit target two bullets - Safety on / unload Open  
Action/cylinder Bench Rest - Muzzle Pointed down range**

**Student will provide 50 rounds of ammunition, Concealed Carry Holster,  
Protective Ear Cover , and Protective Eye wear.**



**POST CM - Human Target or suitable silhouette/marksmanship  
target replacement**

**Proficiency Score 80 % or Better**

***Course may be modified to suit a 50 foot bulls eye paper target Indoor  
Range using .22 caliber ammunition only.***
